Happy Birthday 'the' pill

It is 50 years since the pill was first approved as a contraceptive, finally divorcing sex from pregnancy. But half a century on, our relationship with the tablet credited with revolutionising women's lives is not always an easy one. On 9 May, 1960, the American authorities announced they would allow a hormonal pill previously used for

gynaecological complaints to be prescribed as contraception. Over the next decade, a string of other Western countries from Australia to the UK would follow suit.

What is major trauma?

Major trauma can be defined as physical injury caused by events such as road traffic accidents, falls, explosions, shootings, or stabbings. It describes multiple injuries involving different tissues and organ systems that are, or could be, life-threatening or life-changing. Major trauma is different from general or emotional trauma: it does not include injuries like a broken arm or leg, or a fractured rib.
